Sub: Recognition to the school from class VI to VIII (without aid) w.e.f. ACADEMIC SESSION 1993-94.

Sir,

With reference to your application on the subject noted above. I am directed to convey the approval of the Director of Education Delhi to grant recognition to your school from Class VI to VIII (without aid) w.e.f. 1/4/93 subject to the fulfilment of the following terms and conditions:

1. That the actual school shall strictly abide by the provisions of DSEA & R, 73 framed thereunder as well as the instructions issued from time to time by the Department.
2. That the school shall admit students without any discrimination of caste and creed.
3. That a proper library shall be established and facilities for the reading room shall also be made available to the students as well as the teachers. Books in the ratio of 10 books per student shall be purchased and made available to the students.
4. That adequate sports material shall be purchased and made available to the students.
5. That the employees of the school will be given pay and allowances and other prescribed benefit as provided for under section 10(1) of the DSEA, 1973 and Rule 125 of D.S.E.R., 1973.
6. That the school shall not run any unrecognised classes or conduct any other activities within the school premises as per Rule 50 of DSEA, 1973 and all the recognised classes shall be run at one place.
7. That the school shall dispense with the services of untrained and over aged staff, if any, immediately, and the required staff strength must be complete in all respects as per norms.
8. That the school shall submit the returns to the Joint Director of the Dts. of Education as per rule 160(1) of D.S.E.R. 1973 annually.
9. The Managing Committee shall regulate the functioning of school strictly in accordance with the provisions of DSEA and R, 1973.
10. The Managing Committee of the school shall not increase fee in the future academic sessions without the prior intimation of the Director of Education who is under no requirement under subsection 17(3) of D.S.E.R. 1973.

- DSER, 1973 shall be made available to the students.
12. Proof to the effect that qualified staff has been provided as per R.R.S. be provided for verification by the E.O.
 13. That the staff shall be paid all arrears and shall be as per the fourth Pay Commission pay scales, proof shall be given to the E.O. for verification.
 14. That the arrangements for good drinking water shall be made for all the students as well as the staff and sanitary facilities shall also be provided to the students and staff adequately.
 15. The school shall have the medium of instruction as per Rules 5, 7 and 8 of DSER, 1973.
 16. Provident fund Register shall be maintained and the book completed and shown to the E.O. of the Zone concerned for verification from time to time.
 17. That the management of the school shall create a reserve fund of Rs. 50,000/-.
 18. That the violation of any instructions/conditions/rules and regulation of the Department shall lead to action against the school as per Section 21 of DSE Act, 1973.
 19. That report about the fulfilment of the above conditions be sent to the E.O. every year.
 20. That the school shall equip the science laboratory as per the norms of the Department and suitable facilities for practical work shall be provided to the students.
 21. All the conditions of recognition under section 4 of the Act will continue to be complied with.
