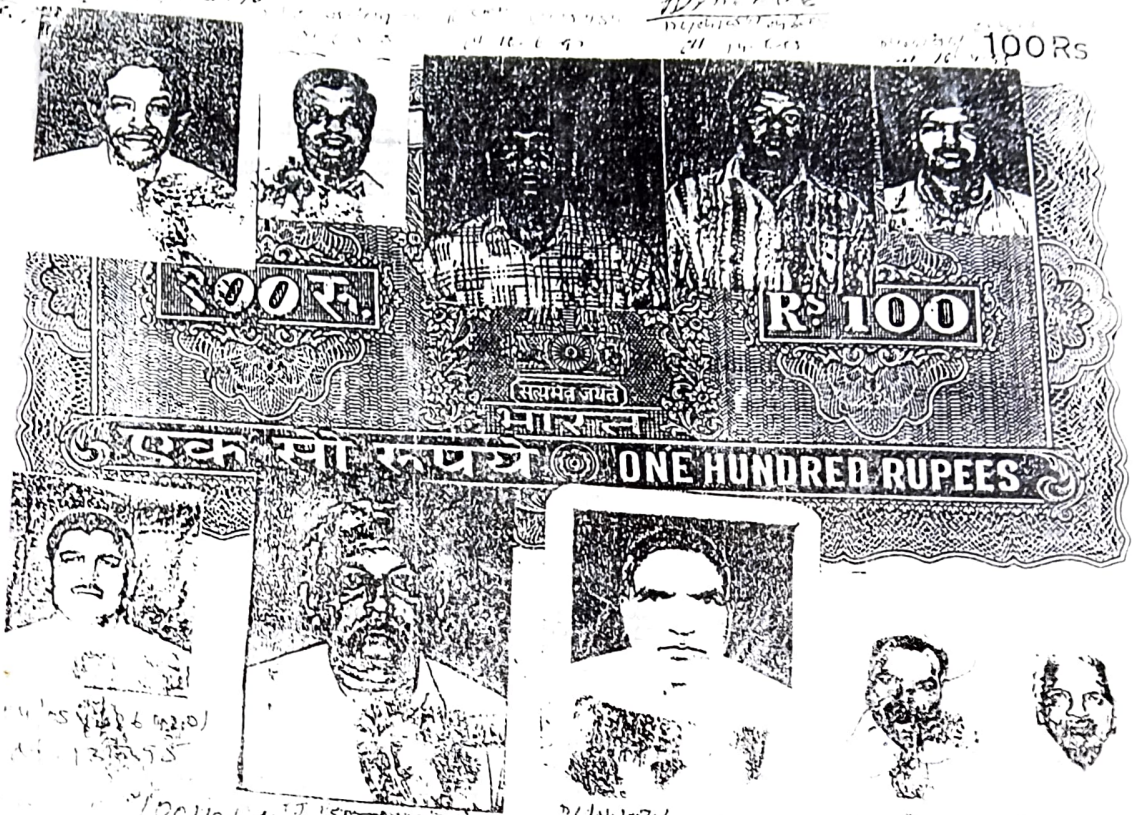

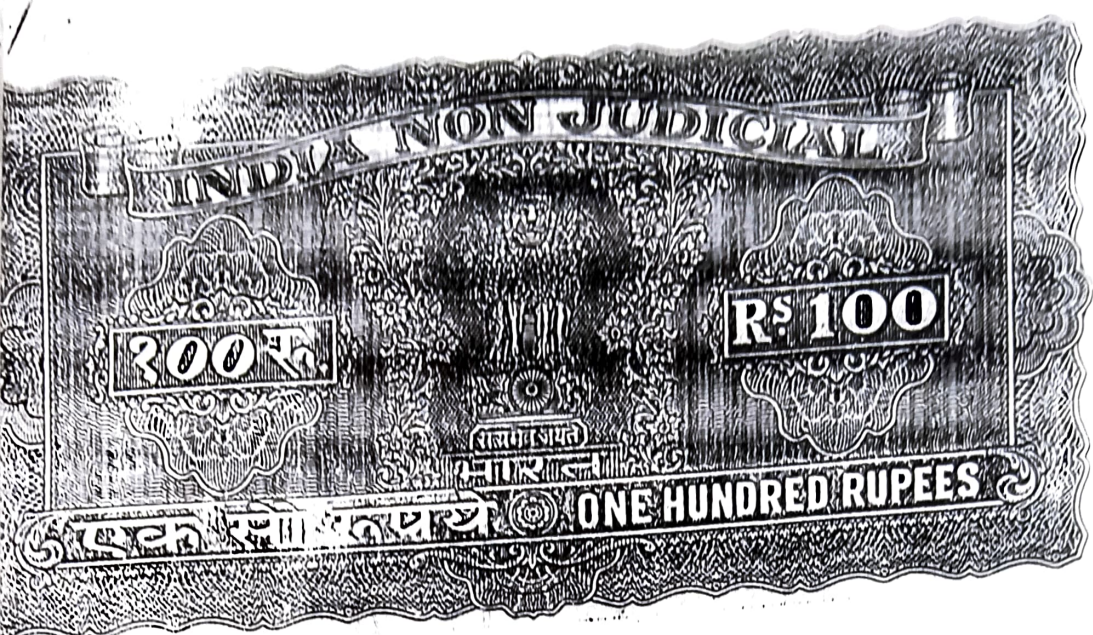

- (ii) To work for the promotion of Indian Culture in the schools run by the Trust, and
- (iii) To promote the cause of conservation of environment, small family and health and hygiene in the school run by the Trust.

4. The Trustees shall keep the account or accounts of the Trust in one of the nationalised Bank and the said account or accounts shall be operated jointly by the Chairman and the Treasurer and in the absence of the Treasurer, the account shall be jointly operated by the Chairman and one Trustee so authorised by the Trust.

5. The financial year of the trust shall end on 31st March, every year provided that the Board of Trustees shall be at liberty to change the same from time to time if they so deem fit and proper. The first financial year of the trust shall close on 31st March, 1999.
6. The trustees shall from time to time after meeting the expenses of and incidental to the management of the Trust Properties and of the Trust decide the particular object or objects for which the income or corpus of the Trust Fund or Properties for the time being available shall be applied.
7. The trustees may accept any donation or contribution in cash or in kind from any person, firm, company, corporation, associations, institution or trust (including the settlor or the trustees or any of them) for the furtherance of the objects of the trust or for any one or more of them upon such terms and conditions as they may, in their absolute discretion think fit and which are not inconsistent with the object or objects of the trust. The trustees may also take over the management of any other charitable or public institutions on such terms as they think fit and may manage such institutions.
8. Without affecting the generality of powers and functions of the trustees to manage and administer the trust, the Board of

trustees shall have the following functions :-

(ii) To borrow if needed be against the security of the assets of the trust by way of bank overdrafts, loan or otherwise, as may be necessary, for the benefit of the trust and for more effectively carrying out the objects of the trust provided however the trustees unanimously agree on such borrowing and limited to the terms of their decision or agreement and to authorise two or more of the trustees to execute such documents, deeds, papers, etc. as may be necessary in connection therewith.

trust matters in such manner and subject to such rules and regulations as the trustees may prescribe.

To authorise any one or more trustees to hold any property or any fund or any investment of the trust subject however to the terms of these presents in such manner and subject to such terms and conditions, rules, and regulations as the Board of Trustees may from time to time think fit and proper.

If the income from the trust property in a particular year is not fully utilised, the unexpended income subject to the applicable provisions of the Income-tax Act, 1961, shall be carried over to the next year or years and spent in such subsequent year or years for the advancement of any of the object of the trust.

The trustees may appoint Secretaries, Managers, Lawyers, Accountants, Auditors, Architects, Engineers, Surveyors, Clerks or other employees for the purpose of management and supervision of the Trust Estate, for collection of rents, profits and profits, for keeping the accounts and records and for other purpose of the trust.

The trustees may establish its office at such place or places and may change such places from time to time as they may think fit.

All the trustees unless they voluntarily resign or otherwise decide, shall continue to be the trustees during the term of their natural lives.

The number of Trustees shall be not less than two and not more than seven.

Any trustee may retire at any time without assigning any reason and without being responsible for any costs occasioned by such retirement.

12. The trustees at a meeting shall form a quorum for any meeting of the trustees.

13. The trustees for the time being shall elect from amongst them a Chairman and he shall hold office during his life time, unless he resigns or refuses to act as Chairman or otherwise ceases to be trustee. The Chairman may appoint one Secretary and one Treasurer from amongst the Trustees, who shall carry out the business of the Trust as specified by the Trustees from time to time. Their term shall be initially for five years, but if the trustees so desire and resolve, their term may be extended further to such a period as decided by the trustees.

14. All proceedings and questions and matter arising at the meeting of the trustees shall be decided by a majority of votes and in case of equality of votes the Chairman shall have a second or casting vote PROVIDED HOWEVER that notwithstanding anything herein stated no question dealing with the disposal of the corpus of any of the trust
