Sir,

With reference to your application on the above cited subject, I am directed to convey the approval of the Director of Education, Delhi, for the upgradation of the existing Secondary School to Senior Secondary Level (without aid) with Humanities and Commerce Stream w.e.f. 2001-2002 subject to the fulfillment of the following terms and conditions :

1. That the school shall abide by the provisions of DSEA & R, 1973 as well as the instruction issued from time to time.
2. That the school shall admit students without any discrimination of caste and creed.
3. That the school shall meet the additional liability of Sr. Secondary classes.
4. That the school Library shall maintain books at the ratio of 10 per student.
5. That the adequate sports material shall be purchased and made available to the students.
6. That the school shall strictly abide by the provisions of section 10 (i) of the DSEA & R 1973.
7. That the school shall not run any unrecognised classes or any other activities in the school premises and all recognised classes shall run at one place.
8. That the school shall dispense with the service of unqualified and overaged staff immediately.
9. That the Managing Committee shall regulate the functioning of the school strictly in accordance with the provisions of DSEA & R 1973.
10. Managing Committee of the school shall not increase fee during academic session without prior approval of the Director of Education which is mandatory under sub section (5) of section 17 of the DSEA & R 1973.
11. That the society shall apply for land to DDA for establishing schools as per laid down norms.
12. That the school shall enroll students in each section such that each student gets 10 square feet of the room.

13. That all the conditions of the rule 50 of DSEA & R 1973 shall be fulfilled and facilities under rule 51 of DSEA & R 1973 shall be made available to the students.

14. That proof of the effect that qualified staff has been appointed as per RRs be provided for verification to the E.O.

15. That the arrangements for good drinking water shall be made available to all the students as well as teachers and sanitary arrangement as per norms made in the school.

16. That the school shall comply with the norms of the CBSE for affiliation for examination purposes.

17. Medical facilities, leave, LTC, bonus, teaching allowances, provident fund and other related facilities by provided to the staff as per Govt. norms.

18. Provident Fund Register will be maintained and cash book completed and shown to the E.O. of the Zone concerned for verification from time to time.


19. That the violation of any rules and regulations of DSEA & R 1973 and instructions of the department shall lead to the withdrawal of recognition of the school.
